## **Fr. David Hiller High School Scholarship**

Effective January 1, 2012, the Fr. David Hiller Fund will offer two (2) \$2500 grants to children of **active** Kolping parents. Grants are available for children who will be freshmen at a Greater Cincinnati Catholic High School in the school year 2012-2013. These grants will be renewable for each successive school year provided certain conditions are met.

In 2012, the grants will be awarded to the two freshmen students. Current grant recipients are also required to reapply in order to receive their renewable grants. Applications and program description will be available in the Hiller fund mail slot in the Kolping Board room after January 1. Applications should be sent directly to the Cincinnati Scholarship Fund who will determine the awardees. Deadline is April 30, 2012. **2011 Kolping Board Highlights**

Under the direction of Our President Larry Fehrenbach, VP Christa Olding, Secretary Charlie Lintz, Treasurer Jim Schnieder and our Praises Mr. Bruno, the Board would like to share its highlights:

After Plan 2000 was written, it seemed that there were two lingering or unresolved issues that needed to be addressed:

Firstly, the budget should be balanced. Much cost cutting was accomplished by Jim Schnieder, such as, saving about \$15,000 per year for four years on real estate taxes, \$8,000 per year on the electric bill and as Chien Vu put it, and “We should try to make our events cost-neutral”. The Appreciation Party was a huge success with great food yet we charged for drinks and there was not one complaint. The balancing of the budget will continue as we look for both ways to save and ways to increase our income. As Gary Koester put it “It is preferable to consider new revenue ideas than to look forward to a future of rigorous cost control.”

Secondly, we need to increase our ability to quickly and often keep our membership informed. Chris Schnetzer has sent out e-mail blasts to promote events and it seems attendance increases for those events. Also, Mike Siebel has taken over the Kolping web site and promises prompt updates and a new look.

A survey was taken and we have a better picture of where the interest of our membership lies.

The entire board spearheaded by Phil Neumann, has spent countless hours to get a formalized agreement with the Kolping Park and Cincinnati Catering that will guarantee us a steady income. Tom Musbach has started the ball rolling for changes to the by-laws that will make running for office more desirable, make general membership meetings more enjoyable and allow for a more modern look of our society.

Thanks to the efforts of Beth Hoffman, hall rentals have set an all-time high bringing Kolping much needed funds.

The Schuetzen group even cancelled their End Party allowing more money to go back to the Society.

The Schuetzenfest had a turnout which resulted in great revenue.

Membership is up from last year despite a few deaths.
