A Letter from the President

Dear Kolping Members,

Over the past several years, our Society has faced growing financial and operational challenges—many of which have come into sharper focus through our recent financial assessments and ongoing Board discussions. While our faith and fellowship remain strong, it has become increasingly clear that we must adapt in order to secure the long-term health and sustainability of our organization.

What many may not realize is that the Cincinnati Kolping Society operates with an annual budget in excess of \$1 million dollars. That figure reflects the full scope of what it takes to maintain our facilities, programs, and activities. Just consider a few examples:

- We pay around \$52,000 each year in real estate taxes.
- Our utilities and insurance exceed \$63,000 annually.
- Repairs and maintenance surpass \$110,000 per year—and that doesn't even account for the countless hours donated by our Tuesday Worker Crew.

These are the baseline costs of simply keeping the lights on and the doors open. Relying solely on Schützenfest and member-led fundraising is no longer sustainable. We must grow beyond our traditional funding sources and actively develop new revenue-generating opportunities, especially through responsible business operations that leverage our property and assets year-round.

To move forward effectively, we need to revise how we govern, operate, and carry out our mission. That's why the Board has unanimously approved a comprehensive update to our Bylaws—designed to:

- Strengthen financial oversight and operational accountability
- Modernize our governance structure utilizing written and published policies and procedures
- Change Board structure, introduce revised term limits, and extend Board terms from 2 to 3 years to ensure continuity and leadership renewal
- Reaffirm our mission and better align our activities with Fr. Kolping's mission

Your participation is essential. The revised Bylaws will be reviewed for the last time at our General Meeting on Friday, August 1st at 7:30 PM. Following that review, the proposed Bylaws will be brought to a membership vote on Friday, September 12th at 7:30 PM. We urge all members to attend and support this important Bylaws revision process.

This is not just a vote about Bylaws—it is a vote about our future. A vote to preserve what matters most while making the changes necessary to move forward. With your support, we can turn a time of challenge into a moment of renewal and opportunity.

On behalf of the Board, thank you for your continued commitment to the Cincinnati Kolping Society. Let us rise to this moment together with purpose, faith, and unity.

- If the Bylaws revision fails, we will need to elect a new President, Vice President, and 5 Directors under the existing Bylaws structure.

This is an important moment for the Kolping Society of Cincinnati, and we are counting on strong leaders to guide us into the next chapter. If you are interested in serving in any capacity, please reach out to any current Board member. Once the Nominating Committee is established, they will oversee the formal nomination process.

Important Deadline:

All nominations must be submitted before the October 2025 General Meeting, as the ballot will be closed at the end of that meeting. The election will be held at the November General Meeting.

Message from Our Praeses, Fr. Dan

Today, July 23, 2025, we began a series of days when the Gospel readings for daily Mass narrate how Jesus used parables to teach his contemporaries about living as his disciples. (Mt 13:1 to Mt 13:53)

Today's reading (Mt 13:1-9) is the parable about a sower spreading seed in a carefree way, with no apparent concern about where the seeds might fall. Rocky ground, thorny places, shallow soil are places where the seed can't grow. But some of the seed falls on good ground and yields a good harvest.

Tomorrow (Mt 13:10-17) Jesus explains why he speaks in parables. It is so that some may hear and not understand while others may grasp his meaning. Then, on Saturday (Mt 13:24-30), there is the enemy who comes at night and sows weeds that grow up and choke the grain, creating the difficulty of separating the weeds from the wheat at harvest time.

I point to these first three of the series of parables in Matthew's Gospel because they do make us think. They ask us, today's readers, to reflect about what is happening in our lives. Are we allowing the seed of God's word to grow? Or, are we placing obstacles in the way of growing our faith?

Just today I saw a message asking this question: "Do you know whether the road you are travelling on leads to heaven or to some place where you don't want to go?" Think about that. God bless.

Kolping Name Badges
