Letter from the President

Dear Kolping Members,

Our Kolping Society continues to evolve with purpose and momentum. I'd like to take a moment to share several important upcoming activities, recent successes, and events that are shaping the future of our Society.

Upcoming Activities

1. Bylaws Update - Membership Vote on May 2nd

At our upcoming General Meeting on Thursday, May 2nd, members will be asked to vote on the proposed updates to the Society's Bylaws. These proposed revisions, shared with all eligible voting members via email or regular mail in April, were also discussed during the April General Meeting. The Bylaws update is the result of months of thoughtful review and discussion by the Board, aimed at modernizing our governing documents to better reflect the needs and operations of our Kolping Society today and into the future. Updating our Bylaws ensures that our structure, policies, and responsibilities align with current best practices and implement recommendations from the assessment completed last year by Kirsch CPA Group. These changes will empower our leadership to operate more effectively and efficiently.

2. Hiring a Kolping Society Business Manager

The Board has approved the hiring of a Kolping Society Business Manager, with the intent to have this individual in place by June 2025. This new position, announced via email on April 9th, will support the facility, operational, and financial management of the Society, allowing our volunteer leadership to focus more fully on mission and member engagement. As our organization grows and our governance becomes more complex, professional support is essential to ensuring continuity, compliance, and long-term growth. The Business Manager will bring added consistency, transparency, and financial oversight to our operations.

3. Implementing Financial and Governance Recommendations

Following the financial assessment conducted by Kirsch CPA Group, the Board is considering engaging Kirsch to assist with implementing key recommendations. These include enhancements to internal controls, finance reporting structures, and Board oversight mechanisms. Proactively addressing these improvements demonstrates our commitment to fiscal responsibility and sound governance. It helps safeguard our resources, build member confidence, and position the Kolping Society for long-term financial sustainability.

Key Bylaws Revisions Up for Vote – May 2nd General Meeting

At the upcoming General Meeting on **May 2, 2025**, voting members will be asked to approve the Bylaws revisions developed in response to recommendations from the Kirsch CPA Group's financial assessment conducted last year. The Board has worked diligently on these updates for several months, and they were passed unanimously by the Board in March 2025. The proposed Bylaws revision was announced, emailed or mailed to members, and discussed during the review session at the April 4th General Meeting.

Key Changes Include:

- **Board Structure & Term Limits**
Board member terms will shift from two years to three years, with a six-year term limit (two consecutive terms). The Directors will also be reduced from 10 to 9, with 3 Directors elected each year. This replaces the current structure where 5 of 10 Directors were elected annually with no option for re-election.
- **Governance Simplification**
Operational governance will move from the Bylaws to Policies and Procedures, making the Bylaws more concise. This change allows the Board to adjust policies as needed without requiring future Bylaws amendments.
- **Clarifying Subgroup Roles and Finances**
Updates remove ambiguities around the purpose and financial accounting for subgroups, bringing greater transparency and alignment with financial best practices.

These changes are designed to strengthen governance, improve flexibility, and align with the Society's long-term goals.

A **2/3 majority of the quorum voting membership** is required to pass these changes. As a reminder, per our current Bylaws, a quorum is defined as 25 (regular and/or life) members or 10% of the membership, whichever is less.

Your vote is critical—please attend the May 2nd General Meeting!

Kolping Genealogy

We will meet at 2:00 P.M. live at the Kolping Clubhouse on **Sunday, May 18th**. We will host two parts of this *Photo Forensics* session. The first part will feature David Lahrman, who will explain the process of evaluating those old photographs we all have of family members and beginning to identify people, dates and places by leading us through examples from his family. The process, while it can be tedious and time consuming, is well worth the time and effort. The process includes collecting as many family photographs as possible that you can find, digitizing them so that you can study them on the computer screen and reviewing them against other photos and documents that have been collected. We will talk about some of the tools to use and show you examples. This will not be a Zoom session, but live.

Both David and Tom will bring their matching Epson PerfectionV600 Photo Scanners and laptops to then show you how to properly scan your family photos using Epson Scan, the program that comes with these devices. Your task is to bring those treasures from your homes, either black-and-white or color. Do you have *Photoshop* or *Photoshop Elements* from Adobe? We can show you how to scan directly into these programs to enhance your family photos digitally.

This session will undoubtedly run over the usual hour reserved for our sessions, so please be prepared to stay longer. You may bring your laptop and external flash drives to copy your photos.

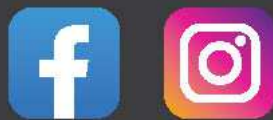
