### A Letter from the President

Dear Kolping Family,

As we approach the November 7th election of our new Board, I want to take a moment to reflect on how far we've come over the past two years and to look ahead at the work that remains. This election marks a time of transition, as my term and half of the current Board, comes to an end.

We are fortunate to have a strong slate of candidates running for open Board positions, representing both long-time and newer members who share a deep commitment to our Kolping Society's mission. The new Board will play an essential role in guiding the Society's direction over the next two years.

When I began my term, I outlined three key priorities: organizational restructuring, operations and transparency, and membership growth. Together, we've made meaningful progress:

- Organizational Structure: We clarified the organizational relationship between the Kolping Society and the Kolping Haus, establishing clearer lines of responsibility and coordination. With the hiring of new Kolping Haus business staff, a Kolping Society Business Manager, and our new Treasurer/CFO working in conjunction with our CPA firm, we've strengthened our understanding of current and future needs and have positioned ourselves for continued financial stability. Continued alignment of our business. membership, and charitable operations should remain an important goal for the new Board.
- Operations and Transparency: An independent financial assessment has been completed, some recommendations have been implemented, consolidated financial reporting has been initiated, and new documented policies and procedures have improved our operations. Continued focus on financial growth and stability, increased facility utilization for revenue generation, and continued documentation and publication of policies and procedures should remain key priorities for the incoming Board.
- Membership and Engagement: Over the past two years, we've welcomed new members, created new subgroups and events, and celebrated Cincinnati Kolping's 100<sup>th</sup> Anniversary. Our subgroups have grown in both responsibility and creativity, expanding opportunities for fundraising and social connection. We have also renewed our focus on Cincinnati Kolping's Catholic mission and values which remain central to who we are. Looking ahead, the next

 Board should continue to expand outreach and engagement among Associate Members, including those involved in our soccer programs and subgroups who may not yet be fully active in our Society. It's important to remember that, per our current Bylaws, Associate Members are members of the Society and their involvement is essential to our shared future.

These accomplishments reflect the dedication of many who have given their time and talents to strengthen our Society. Yet, there is always more to do—especially in developing future membership, ensuring our financial sustainability, and fostering unity within our Kolping family.

# Fr. David Hiller Fund Report (cont'd.)

We are grateful for the many donations that have been sent from our subgroups, in celebration of members' events and in memory of our Kolping members and will use them to continue the work of Blessed Fr. Kolping. We also received donations from the bar tips from events at the Klubhaus and Pavilion.

Once again, the Father David Hiller Fund will offer two (2) \$3000 grants for children of active Kolping parents who will be attending Catholic high schools in the Tri-State area. At least one parent must be a member for at least three years. Grants are available for children who will be freshmen at a Catholic high school in the school year 2026 - 2027. These grants will be renewable for each successive school year provided certain conditions are met.

This year, the Father David Hiller Fund invites students to apply for the scholarship by submitting a 500-word essay explaining why they wish to attend a Catholic high school. We encourage you to reflect on how a Catholic education will support your spiritual growth, academic journey and personal development. This is an opportunity to share your thoughts on how faith, community and service will shape your high school experience and prepare you for the future.

Current grant recipients are also required to update their information in order to continue receiving their renewable grants. Applications and program description will be available in the Hiller fund mail slot in the Kolping copier room or at:

www.Kolpingcincinnati.com under the Father David Scholarship link on the left side of the home page. New applications and current scholarship renewal information should be sent to Father David Hiller Fund, 10235 Mill Rd., Cincinnati Ohio 45231.

The FDHF Board will read the essays and determine the two winners. Names will be removed from the essays to ensure impartiality from the judges. Deadline is February 16, 2026. ## **Kolping Genealogy**

On Sunday November 16 at 2:00 pm, you can learn about one of the most powerful software programs called Family Tree Maker 2024 (FTM 2024). FTM 2024 is a major new Family Tree Maker edition that takes this grand old brand to places its creators could only have dreamed of when it was first published back in 1989. It is the standard for detailed personal genealogy research (https://www.mackiev.com/ftm/).

If you are new to family genealogy, you'll appreciate how this intuitive program lets you easily build your family tree with simple navigation, tree-building tools, and integrated Web searching. If you are already an expert, you can dive into the more advanced features, options for managing data, and a wide variety of charts and reports.

New users might feel intimidated by a program with so many features. MacKiev's FTM24's functions are divided into eight major "Workspaces," accessible from tabs at the top of the screen within the application: Plan, People, Places, Media, Sources, Publish, Web Search, and Connect. Mr. David Lahrmann and Dr. Tom Montgmery will be reviewing two of the eight menus in the new FTM 2024 software program in November. David will concentrate on People while Tom focuses on Places.

We will continue to focus on two of each of these menus every other month, with January being on Sources and Media and March on Web Search and Publishing.
